The BHS Higher Education Society (BHS HES) is a 82 year plus temple of learning established in 1942 by a group of eminent educationists and philanthropists. It is registered as a non-profit body dedicated to the cause of education. Its first concern was to concentrate on programmes essential for educating young boys and girls in Bengaluru. Thus secondary and Pre-University courses which form basic foundation for employment and career opportunities were given prominence in the beginning. In 1942, the first step was taken by establishing the Bangalore High School in a rented building at Visveshwara-puram, Bengaluru. Under the stewardship of its President-Late Rao Bahadur, Prof. B. Venkateshachar, Retired Director of the Indian Institute of Science, Bangalore, and the dedicated efforts of the Secretary Late Dharmaprakasha, L.S.Venkaji Rao, a prominent businessman, the Managing Committee, started the Vijaya College in 1945, in the same premises with the present Pre-University courses. In the span of next ten years, the College moved into its own building in Basavanagudi while the High School was shifted to a leased building in Chamarajapet, thanks to the generosity of His Holiness of Sri Sringeri Mutt. In the following two decades (1955-75), the growing demands of cosmopolitan Bengaluru brought in major developments. These activities called for concerted efforts and resources for running them on solid grounds. Hence between 1975 and 1990, the management had to consolidate the infrastructure of the institution with adequate buildings, laboratories, equipment and other facilities. By 1990, the BHS Managing committee took a leap forward in gearing its educational planning and experience in consonance with National Education Policy in an endeavor for economic and social development. As a follow-up, the society started the BHS FIRST GRADE COLLEGE at Jayanagar during the academic year 1989-90 offering Pre-University and Degree courses in Electronics, Computer Science, Micro Biology, Biotechnology, BCA, Commerce and Arts. A rural education project was embarked upon in June 1990 at T. Narasipura, Mysore District. The Vijaya Computer Training and Data Processing Centre was started for offering short-term certificate courses. Later, while celebrating the Golden Jubilee of BHS HES, Bangalore Institute of Legal Studies was established at Jayanagar in 1993 and later it was shifted to R.V. Road.

HISTORY OF BANGALORE INSTITUTE OF LEGAL STUDIES

Bangalore Institute of Legal Studies was established in the year 1993, the year in which BHS HES was celebrating its Golden Jubilee. It was inaugurated by Shri. B.V. Acharya, the then Advocate General Government of Karnataka. Dr. V.B. Coutinho, the then Dean and Principal of University Law College, Bengaluru, presided over the function. Shri GY Subba Rao assumed office as the first Principal of the college. Subsequently, Prof. Anand Rao of the Department of English served as the acting Principal for a short term. On the 10 of July, 1996, Prof. S. S. Alur, retired Professor of Law, Karnataka University, was appointed as the Principal. His arrival as the Principal galvanized the growth and development of the college. His commendable contribution to the college interms. of his insight, a treasure trove of knowledge, guidance and uncanny expertise has brought this institution to where it is today. Then, Prof. S.S. Alur was designated as the Director and on the 23rd of February, 2000. Smt. C.S. Kanthi assumed office as the Principal of the college. Owing to personal reasons, she passed on the baton to Prof. S.B. Jatti.

On the 26th of September, 2001, Prof. S.B. Jatti, a senior Professor with more than 20 years of experience, assumed the role as the Principal of BANGALORE INSTITUTE OF LEGAL STUDIES. Under his dynamic leadership, BANGALORE INSTITUTE OF LEGAL STUDIES reached great heights and made its presence felt amongst the Law Colleges in the country. He retired in November 2013. Dr. Sapna S. took over from Prof. S.B. Jatti in November 2013.

She continued to work for the excellence of the institution till April 2017. Prof. Preeti S. Desai took over from Dr. Sapna S in May 2017. She is presently the Principal of Bangalore Institute of Legal Studies where she has worked since 2013. She completed her B.Com. and LL.B. in 1997 and 2000 respectively. She completed LL.M. in the year 2002 and secured 3rd Rank in Karnataka University, Dharwad. She is tirelessly working towards improving the college and making it one of the Best Law Schools in India.

Currently, Prof. Preeti S. Desai, is a Professor and Principal of Bangalore Institute of Legal Studies and Editor-in-Chief of the college magazine titled BILS Chronicle

ADMISSION

[U/s 86 r/w S.34 (2) (ii) & S.49 of the KSLU Act, 2009.]

The college imparts legal education for 5 year B.A., LL.B. Degree Course. Students who have secured 45% marks in PUC or 10+2 examination are eligible for admission to the First year BA., LL.B.

Admission to Bangalore Institute of Legal Studies is highly selective. Every year on an average, there are approximately 500 applicants, out of which 60 students are selected purely on the merit of their II PUC marks.

The College is permanently affiliated to Karnataka State Law University (KSLU), Hubballi, second largest Law University in Asia, affiliating 108 colleges spread over the entire State of Karnataka and, approved by Bar Council of India.

Students are required to fill in the prescribed form and enclose Photo Copies of the following documents at the time of admission:

PUC or 10+2 Marks Card, SSLC Marks Card, Caste Certificate.

ELIGIBILITY CRITERIA FOR ADMISSION

A. An applicant who has successfully completed Pre-University course or Senior Secondary School Course ('+2') or equivalent such as (11 + 1, 'A' level in Senior School Leaving Certificate Course) from a recognized university of India or outside or from Senior Secondary Board or equivalent, constituted or recognized by the Union or by the State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the Course.

Provided that applicants who have obtained +2 Higher Secondary Pass Certificate of First-Degree Certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission to the course.

Provided further that the applicants who have obtained 10+2 or graduation or post-graduation through open universities system directly without having any basic qualification for prosecuting such studies are not eligible for admission to the course.

- B. Minimum percentage of marks in qualifying examination shall not be below 45, (44.5 and above shall be treated as 45), of total marks in case of general category applicants and 40 (39.5 and above shall be treated as 40) of total marks in case of SC and ST applicants.
- C. Maximum age for seeking admission is limited to twenty years in case of general category of applicants and to twenty-two years in the case of applicants from SC, ST and other backward communities as on 1st June.

REGULATIONS GOVERNING THE FIVE-YEAR B.A., LL.B. INTEGRATED DEGREE COURSE IN LAW

The Vice-Chancellor of the Karnataka State Law University, Hubballi makes the following Regulations under Section 86 read with Section 34(2)(i) and Section 49 of the Karnataka State Law University Act, 2009:

1. TITLE

These Regulations may be called as "the Karnataka State Law University's Regulations Governing the Five-Year B.A. LL.B. Integrated Degree Course in Law".

2. EXTENT

These Regulations extend to all University Law Colleges, Departments of Studies in Law and all affiliated Law Colleges within the jurisdiction of Karnataka State Law University which are accorded permission to start Five Year Integrated Degree Course in Law.

3. COMMENCEMENTS

These Regulations shall come into force from the beginning of the academic year 2009-10.

4. DEFINITIONS

- a) "Integrated Degree Course in Law" means double degree course comprising the bachelor degree in arts prosecuted simultaneously with the degree course in law in an integrated manner as designed by the University from time to time for a continuous period of not less than five years.
- b) In these Regulations, the expressions, "University", "University Area", "College",

"Affiliated College", "Department", "Department of Studies", "Post Graduate Department", "Post Graduate Department of studies", "Teachers", "University College" and "Principal" bear the same meanings, as assigned under Section 2 of the Karnataka State Law University Act, 2009.

5. THE COURSE & DURATION

- a) B.A. LL.B. integrated double degree course combines Bachelor's degree course in Arts together with the Bachelor's degree course in Law.
- b) Each Academic year shall be divided into two semesters.
- c) The papers and the syllabus shall be as given in the Schedule appended to these Regulations.

6. INSTRUCTIONS & TRAINING

- a) Instructions and training for the course shall be not less than 30 class-hours per week including tutorials, moot room exercise and seminars, provided, there shall be at least 24 lecture hours per week.
- b) There shall be for each year four class hours of one hour duration each and one hour of tutorial/moot court project work per week.
- c) **INTERNSHIPS:** Each registered student shall have completed a minimum of 20 weeks of internship during the entire period of legal studies under NGO, Trial and Appellate

Advocates, Judiciary, Legal Regulatory authorities, Legislatures, Parliament, other Legal Functionaries, Market Institutions, Law Firms, Companies and Local Self Government.

- d) The internship in any year cannot be for a continuous period of more than four weeks and all students shall at least gone through once in the entire academic period with Trial and Appellate Advocates.
- e) Each student shall keep internship diary in the form stipulated by the University and the same shall be evaluated by the Guide in internship and also a Core Faculty Member of the staff each time. The total mark shall be assessed in the Final Semester of the course in the 4th Clinical course as stipulated under the Schedule appended to these Regulations

EXPLANATION

A College or Department shall be deemed to be working whole time if the working time of the college or University Department extends to at least eight hours continuously on every working day, comprising of classroom teaching of four periods, each period being of one hour duration and the remaining four hours devoted to clinical, curricular and co-curricular activities.

7. ADMISSION PROCEDURES

Admission to the course shall be made strictly on the basis of the merit, taking into account total marks obtained in the qualifying examination. Provided that while making admission to the course reservation

policy of the Government of Karnataka governing admission to higher educational institutions issued from time to time shall be applied.

INTAKES

No College or Department of studies in Law authorized to impart education in B.A., LL.B. Course shall admit more than 60 students in one division.

The University shall reserve the right to prescribe the number of divisions in each Law College or the Department of Studies in Law.

TUITION AND OTHER FEES

Candidates admitted to the Five-Year B.A, LL.B. course and those admitted to such course shall pay the tuition and other fees as prescribed by the University from time to time.

8. CURRICULA

1. Candidates admitted to the Five-Year B.A., LL. B course shall have to attend to semester courses spread over 5 years.
2. In each Semester, the students shall have to study the courses prescribed by the University in these Regulations.
3. The Course descriptions shall be, as set out from time to time, in the Schedule.

9. MEDIUM OF INSTRUCTION

The medium of instruction in the Five-Year B.A., LL.B. degree course shall be in English. However, the examinees shall have the option to answer the

question papers in the examination either in English or in Kannada.

10. ATTENDANCE

No student shall be permitted to appear for the end-of-semester examination in a given course unless he/she has, to the satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 70% attendance in the course concerned.

Provided that a student should have attended not less than 70% of classes in each of the subjects prescribed may be permitted to keep the term for reasons to be recorded in writing and to satisfaction of the Principal of the college or the Dean of the Faculty as the case may be.

11. Prohibition Against Lateral Entry and Exit

There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated double degree course, at any intermediary stage of an integrated double degree course.

12. AWARD OF DEGREE

A student shall be eligible for the award of the BA LL.B. Degree after he/she has successfully completed all the prescribed courses in all the semesters and his or her character and conduct are found to be satisfactory during the course.

1. THE LIBRARY

Bangalore Institute of Legal Studies has an active Legal Aid Cell which conducts Legal Literacy Programme's to students at the undergraduate level and also Legal Aid Programmes in rural areas.

We have an intake of 60 students each year which makes the class small enough for individual attention, yet large enough for interactive discussions. The academic excellence of the students is evident by the ranks and gold medals secured.

Apart from classroom teaching, we stress on practical exposure through student placements. In pursuance of the same, the Placement Committee has regular internships/placement program.

The academic year is spread out over the course of two semesters each of 6 months duration and between these semesters, there are two vacations of 4 weeks each, during which time, the students are encouraged to join Advocates Chambers/ NGO/ Government Organizations & Law Firms.

The First and Second-year students are recommended to put in their time and effort in research, publication of articles in law journals and sharpening their skills in Moot Court work. In fact, internship and maintenance of the internship diary is made mandatory rule of KSLU, Hubballi.

Placement is next continuous step to the internship program which spells finality to our efforts. This obviously would be for the final year students.

DISCIPLINARY RULES AND REGULATIONS

DISCIPLINE

The students shall strictly observe the disciplinary rules framed by the college/management which may be framed from time to time. Non-compliance of these rules will be dealt by the Principal/Dean in the manner he/she considers fit and his decision will be final in such matters.

1. Students are required to maintain the highest standard of behaviour and discipline both inside and outside the College
2. Uploading unacceptable material on the Internet is prohibited.
3. No student shall enter the class or leave the class without the permission of the faculty.
4. Students having no classes shall not loiter in the corridor but are expected to spend the time in the library.
5. Faculty class-in-charge will keep a close watch on the student's attendance, progress, conduct and will look after their general welfare.
6. Irregular attendance, indifference in regard to class work, tests and examination, discourtesy towards the teachers, obscenity in word or act, willful damage of college property, anti-social activities etc, are liable for disciplinary action which will include expulsion from the College.
7. Students participating/preparing for Moot Court should attend their classes and they will be permitted to use the library after the classes.
8. Students who are late to the class will not be permitted to enter the library nor to loiter in the Corridor.
9. Students should not give the college address for any personal correspondence. The College will not be held responsible for the loss of any letter, whatever be the nature of the correspondence. Letters to the Principal should be accompanied by reply postage whenever a posted reply is desired.



ATTENDANCE

1. Every student shall attend not less than 70% of the prescribed number of working periods in each of the subjects, comprising the course and the Practical Training classes.
2. Each semester shall be taken as a unit for the purpose of calculating attendance.
3. Students who fail to satisfy 70% of attendance shall not be eligible to take the final examination conducted by KSLU, Hubballi.
4. Attendance to the College functions, Association, Meetings, College Assembly, Seminar, Guest lecture, Court Visit, Viva Voce etc., is obligatory to all students.

TESTS & CLASS EXAMS/ASSIGNMENTS

1. Attending and passing monthly tests and preparatory examination is compulsory.
2. If any assignment or paper presentation assigned to any student, he/she should submit it.
3. Students are expected to refrain from the use of tobacco, alcohol, drugs or any other intoxicating substances.

CONSEQUENCE OF IN-DISCIPLINE

Students who are found to have committed any act of indiscipline is liable to any one or more of the following punishments

- c. Cancellation of Scholarship/Concession etc.
- d. Recovery in partial or complete loss due to damages to the College property or property of others inside the college campus caused by the delinquent student.
- e. Removal, rustication or expulsion from the college.
- f. Withholding of Certificates.

The punishments are liable to be inflicted at the discretion of the Principal, whose decision will be final.
